Otero College (OC)

- The biggest update from Otero College is that Dr. Alvarez has announced his retirement, so Otero is currently searching for our next president. On campus, interviews are set to take place from the end of next week through the end of April and the system office is hoping to have the Final selection done by the beginning of May. Dr. Alvarez's last day will be August 11, 2023.

Pikes Peak State College (PPSC)

- PPSC is launching a new Dental Hygiene AAS along with the Delta Dental Oral Health Center estimated Fall 2024.
- Congratulations to Dean Kris Johnson (Natural & Physical Sciences) on her retirement. We will see additional changes to our dean team this summer/early fall. A formal announcement will likely follow.

Arapahoe Community College (ACC)

- ACC is expanding its programming to address critical healthcare workforce shortages. Renovations to the Annex Building will commence our project to develop the ACC Health Innovation Center. The expansion of our on-site healthcare programs is necessary to best serve students, residents and healthcare industry partners in Arapahoe and Douglas counties. This project is central to our mission of preparing

students for academic and career success while serving our communities now and in the future through the development of a talented healthcare workforce.

- ACC Associate Provost & Dean of Communication, Humanities, and Art & Design, Dr. Danielle Staples, has been selected to participate in the 2023 Western Academic Leadership Academy. The Academy is a year-long professional development program for academic leaders aspiring to become chief academic officers in the WICHE (Western Interstate Commission for Higher Education) region's post-secondary sector.
- ACC alumnus Evan Griesheimer (Multimedia, Graphic Design & Illustration transfer student; Computer Graphics certificate) was selected as one of two winners for the design contest for Colorado's 150th anniversary license plates. Griesheimer was awarded a \$1,000 grant from the Department of Motor Vehicles. The plates will be available for purchase beginning in August 2023. More than 300 entries were submitted, and over 30,000 votes were cast to determine the winning designs.

• Secondary Liaison (rural) – Alyssa Horlick

Rural CTE Questionnaire saw an increase of 10 responses since CACTA conference. I have received 38 responses out of 147 school districts. I received a list of contacts that attended the CACTA conference from Jessica Bright and in the process of updating the contact list. There is an interest in Rural CTE programs meeting virtually or in person by region - could be the consortia. However there are concerns about having substitutes to cover their classes while attending these meetings. Dates for regional meetings have yet to be set. Common themes: teacher shortages, turnover, wearing many hats, exhausted/overwhelmed.

Hopes that regional meetings will create community.

Suggestions: pair rural districts with larger "buddies", model FCCLA approach

Secondary Liaison (metro) – Shelley Goerdt

Similarities with rural - teachers are exhausted, wearing multiple hats, seeking connection to experienced programs

Started a small community of metro folks to discuss topics and issues facing our districts. Currently we discuss program approvals, data, CDIP and teacher shortage.

JeffCo offers academic credit for CTE courses - was told by the state that they cannot count.

- Eg. Plant Science addresses academic credit and CTE as they align with both sets of competencies and standards.
